Club President's Message

Halloween has already come and gone and Thanksgiving is fast approaching. There are lots of things going on in the club:

- 1. **Canoa Ranch Courts**: Effective immediately, court 3 at the Canoa Ranch pickleball courts is now available for "Open Play" (paddle up) all day, every day except for three 1-hour blocks starting at 1:00 PM and ending at 3:00 PM weekdays. The three 1-hour afternoon blocks of time can be reserved by sending an email to reservations@gvrec.org. (Note: the email address was incorrect in the club email notification that was sent out on November 2nd.). Additionally, courts 1 and 2 are now available to be reserved in Pickleball Plus at 1:00 and 2:30 on week days. Court 4 will continue to be "Open Play" all day. See "Court Schedules" below for more detailed information.
- 2. **Proposal for New Courts at Canoa Ranch**: The Club's proposal for four new courts at Canoa Ranch was included in the 2025 GVR Budget that the Board of Directors passed on October 23rd. No GVR funds were included in the budget as per our proposal to fund the construction of the courts if / when we can raise the money for the construction. The next steps are to a: enter in to a Memorandum of Understanding (MOU) with GVR and b: begin the fund-raising campaign. The BOD has established a steering committee to oversee all efforts related to the project and the work has already begun. Please send me an email if you are interested in participating in the planning and execution of the fundraising effort.
- 3. **Club Survey**: The club survey is now over. We received over 300 responses and the BOD and I express our thanks for taking the time to complete it. The answers and comments you all provided will help the BOD set priorities for efforts for this season and beyond. Each and every response will be reviewed and considered for action. Additionally, for those of you who indicated an interest in volunteering in specific areas we will be forwarding your information to the relevant individual or group.
- 4. **Technology Corner**: Our club is blessed with amazing technology, much of which is home grown and owned by the club. The club's board of directors (BOD) is cognizant of the importance of keeping and growing our legacy in this regard and we are grateful to those members who developed it, maintain it and help support it in so many ways. We are always looking for volunteers who are tech savvy to help us in this endeavor.
- 5. **Arizona Pickleball Players League (APPL):** Carol Hammerle, the club's APPL coordinator, and two members of the women's 4.0 State Champion Drop Squad team recently conducted an informational meeting regarding club member participation in APPL. Although APPL is not a GVR or club-sponsored organization, several men's and women's teams are in the process of being formed. 9. **Pickleball for students in Green Valley / Sahuarita:** I received the following request from Lenny Friedman, USA Pickleball Education Ambassador for Green Valley/Sahuarita, Arizona (Lenny can be reached at lenny.pickleball@gmail.com.): "This school year, I have volunteered to teach pickleball in an after-school program at Continental School on Thursdays from 2:45pm - 4:45pm from October 17 - December 19, 2024 and March 20 – May 22, 2025. Are there GVR pickleball players who would like to volunteer to help teach the kids pickleball?" I think this is a good opportunity to engage with our larger community.

In this regard, the club has been granted permission by GVR to host the end of school year Spring Tournament for Community Youth in May 2025. 10. **Courtesy, Etiquette and Conduct**: As happens every year around this time many folks are returning to Green Valley and the pickleball courts. Please be courteous and respectful to each other. I have been made aware of a few isolated incidents where players have been confronted by other players regarding perceived infractions. Some of the confrontations have been aggressive and inconsiderate at a minimum and are not acceptable.

If you have a concern, notify the GVR Facility employee (COA – Yellow Shirt) and let them know the issue and let them handle it. If it is not something that a COA can or should address – such as whether or not someone can play in a Round Robin – contact the coordinator for the event and have them address the issue. In any case – all interactions on the court should be kind and considerate. Finally, If you have experienced being confronted by someone other than the GVR Facility employee (COA) or designated others in an inconsiderate manner on any of our courts please file an incident report with the club (greenvalleypickleballclub@gmail.com)and also with GVR (as appropriate).

Reminder: Priority use of courts

Although our club is privileged to have 36 courts, there are certain times that there will be high demand for the same courts. Club membership is now almost 1,100 people.

As our 36 PB courts begin to fill up for the winter season I would like to remind players of individual court use priorities:

Court use schedules can be found on the home page of the club website and on PB+ in the courts tab.

Priority 1 - play format* assigned on the schedule (and skill level if assigned)

Priority 2 - skill level (if assigned)

Priority 3 - anyone else

* play formats are defined at the bottom of the court schedules on the club webpage.

Court assignments are designed to incorporate the multitude of skill levels and interest groups among our players.

Continue to stay tuned to the court schedules and pickleblast for any future court schedule changes. As always, thank you for your continued cooperation.

Court Schedule Changes:

1. APPL (Arizona Pickleball Players League)

Practices for the APPL League teams start in November. Certain courts have been designated for league practice during the afternoon hours. Here is an example of how this looks on Pickleball Plus:

AP-4.0-50+-KB cts 9-11

And here's how to read it:

APPL 4.0 / 50+ / Kathy Burns captain / courts 9-11

Note: All APPL practices and home matches are scheduled in the afternoons at the PBC or East Center. Home Matches will run from January through March (also in the afternoons). There are currently eight Green Valley teams registered with APPL. Stay tuned...there could be more.

2. Lobster court 17

By popular request...use of court 17 for various play formats has been adjusted. The new schedule for lobster reservations is reflected on Pickleball Plus.

3. Mixed Skill Level Play (MSLP)

Although a popular format during the summer, the "mixed" level play ends its run on October 31. Please follow regular Skill Level Play.

4. Play Format

During prime time, all skill levels have Open Play (OP) (aka Paddle-up) and Round Robin (RR) play formats available. Please check the court schedules for which day and location each level plays and the play format on:

- → Pickleball Plus (<u>Pickleball Plus</u>),
- → the club website (gyrpickleball.org) OR
- → the monitor in the PBC breezeway.

5. Canoa Ranch Court Reservation Update

The reservation process for the courts at Canoa Ranch is being adjusted to accommodate prime time play for the upcoming fall/winter season. What's changing?

- ✓ Courts 1 and 2 which are typically "open play" can now be reserved on weekdays for either the 1pm or 2:30pm time slots. Reservations are made on <u>Pickleball Plus</u>.
- ✓ Court 3 as noted above is now an "open play" court at all times except for 3 one-hour blocks (1pm, 2pm and 3pm) on weekdays. The court can be reserved for "recreational play only" for those times by sending an email to reservations@gvrec.org.
- ✓ Court 4 will continue to be an open play court throughout the day.

The Club offers a Developing Skills program to active 2.0 & 2.5 GVR and club members looking to learn and improve their skills.
